For the past 25 years, Air Charity Network / Angel Flights / Mercy Flights / Air Care Alliance 501 (c)(3) Organizations have flown over 320,00 flights and more than 42 million miles of humanitarian, medical, and emergency flights assisting people in need across North America and the Caribbean.

Pilots' charitable gifts, which donated their time, aircraft, fuel, and operational costs to fulfill these missions, have helped. Despite their significant contributions, many tasks require more available pilots or airplanes, which can be deployed on short notice 24 x 7 x 365 days a year.

The impending financial crisis has and will continue to aggravate the need for a dedicated fleet of pilots and aircraft that can transport organs, cancer patients, and clinically compromised individuals. These lives depend on general aviation flights as they can't fly commercially due to their immune-compromised systems or the severity of medical conditions.

SAVI Ministries is expanding its mission to include establishing wellness centers in Central and South America, including Costa Rica, Colombia, and Argentina. These centers will offer advanced treatments, combining alternative and regenerative medicine with spiritual and holistic health education, addressing the urgent need for true health solutions in underserved regions.

Statistics in the United States

In 2023, over 1,287,050 deaths, over a 20.35% increase since 2021 in the USA, were most likely preventable, stemming from conditions such as Cancer, Type II Diabetes, and Heart Disease. 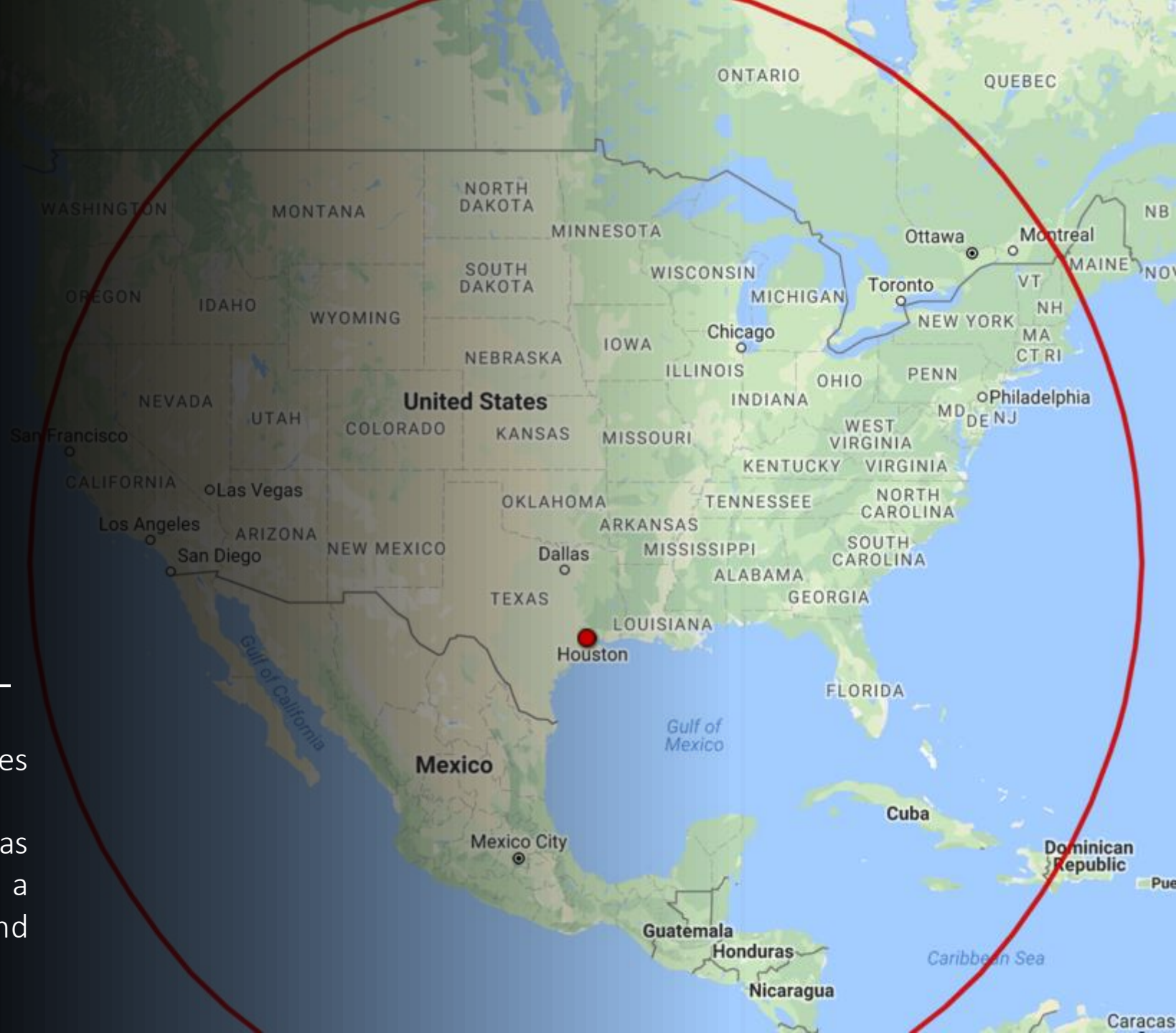
